- Motion made by Supervisor Gary Frankiewicz to Approve Driveway Permit for Tom & Julie Foss access to Town Road from Ojibwa Road (gravel driveway), seconded by Supervisor Jon Johnson; motion carried unanimously.
- Chairman sent notices to Bulik's Mobile Home Park Mobile Home Owner Tenants with past due Personal Property Taxes. Chair will communicate with Mrs. Bulik upcoming change with Mobile Home License.
- Motion made by Supervisor Gary Frankiewicz to post opening for Right-of-Way Mowing Driver of 21 miles on Town Roads beginning Summer of 2021 at \$20 per hour, seconded by Supervisor Jon Johnson. Motion carried unanimously.
- Discussion of responsibility of maintenance on existing culverts located under private driveway access to Town Roads. No precedent found when looking into neighboring Washburn County townships to cover costs. Town of Spooner will not cover any costs.
