ORDINANCE No. 05-14-2019

FIRST AMENDMENT TO

SPOONER LAKE BOAT LAUNCHING FEE ORDINANCE

Amending language of and restating SECTION 3 and

Adding Additional Sub-section (e) to

SECTION 3, Season Launch Pass

WHEREAS the Town Board of Supervisors of the Town of Spooner, Washburn County, Wisconsin, has the specific authority under s.60.22(1), Wisconsin Statutes, to adopt this ordinance amendment to expand and restate the Season Launch Pass regarding the boat launching fee to Spooner Lake located within the political boundaries of the Town of Spooner.

NOW THEREFORE, The Town Board of Supervisors of the Town of Spooner, Washburn County, Wisconsin, does adopt this First Amendment to the Spooner Lake Boat Launching Fee Ordinance No 08-13-2018 , said First Amendment adopted by a majority of the town board on a roll call vote with a quorum present and voting, and proper notice having been given, in order to promote the protection of Spooner Lake from infestation by aquatic invasive species including infestation of said lake by the Zebra Mussel, the Town Board of Supervisors ordains as follows:

SECTION 3. Season Launch Pass. As an alternative to the daily Boat Launching Fee of SECTION 2 Boat Launching Fee, a Season Launch Pass is available only to (a) Town of Spooner Residents and (b) to non-residents who own real estate within the Town of Spooner. The Season Launch Pass is good for the remaining days in the issuance year upon the payment to the Town Clerk of a yearly/season Twenty Dollar (\$20.00) Fee. The Season Launch Pass is available at the Town of Spooner Town Hall located at N6124 Blooming Vale Road, Spooner, WI (with a mailing address of Post Office Box 578, Spooner, WI 54801) from the Town Clerk for the yearly fee of Twenty Dollars and no/100 (\$20.00). The Season Launch Pass is not prorated and is good only for the calendar year in which it was first issued by the Town Clerk. Season

Launch Pass is not available to non-residents of the Town of Spooner unless the non-resident owns real estate located within the political boundaries of the Town of Spooner.

- (a) The Season Launch Pass Fees paid to the Town of Spooner shall be used to provide and maintain the supplies of Deposit Envelopes, the Season Launch Pass card(s), to maintain the equipment of the Lock Box Receptacle /Post, to make repairs to the boat launching ramp and to make repairs/replacement to the removable dock at the boat launching ramp and for such other costs and expenses to facilitate the goals of Ordinance No. 08-13-2018, as amended.
- (b) A new Twenty Dollar (\$20.00) Fee is required to be paid to the Town Clerk for the Town of Spooner for each annual and any subsequent Season Launch Pass renewal.
- (c) Each Season Launch Pass shall identify the owner thereof and the singular boat identified by either serial license number or other identification as to the make and/or model of boat to which the Season Launch Pass shall apply. A Season Launch Pass may not be assigned by the Owner to another subsequent individual nor transferred to another boat or water craft. In the event of the loss of an issued Season Launch Pass a replacement Season Launch Pass shall not be issued without the payment of an additional Twenty Dollar (\$20.00) Fee.
- (d) The Season Launch Pass, bearing the singular boat identification information, shall be displayed on the dash board of the vehicle used in the launching/retrieval of the boat so that the Season Launch Pass can be observed through the front windshield of said vehicle in the event that said vehicle is parked in the DNR Parking Lot or in the vicinity of Spooner Lake Road and/or County Highway "H".
- (e) A Season Launch Pass holder may obtain an additional Season Launch Pass(s) for designated additional boat(s) owned by said Season Launch Pass holder upon payment to the Town Clerk of the additional fee of Five Dollars (\$5.00) for each and every additional Season Launch Pass(s) bearing the additional singular boat identification by either serial license number or other identification as to the make and/or model of boat to

which the additional Season Launch Pass shall apply. Any additional Season Launch Pass is good only for the calendar year in which it was first issued by the Town Clerk.

SECTION 11 Effective Date This amended ordinance is effective May 15th, 2019.

SECTION 12 Ordinance in Effect The terms and provisions of Ordinance No 08-13-2018 shall remain in full force and affect except as amended in this First Amendment to the Spooner Lake Boat Launching Fee Ordinance.

The town clerk shall properly post or publish this amended ordinance as required under s. 60.80, Wisconsin Statutes.
