SPECIAL TOWN MEETING OF ELECTORS OF THE TOWN OF SPOONER MINUTES

Call to Order at 6:01 p.m. Pledge of Allegiance recited.

Gary Frankiewicz motioned to approve Minutes of April 21, 2020 (Recessed) and May 19, 2020 Annual Meeting of Electors; seconded by Miles Macone. Motion carried unanimously.

Motion to adopt Resolution By Electors to Endorse The Town Board's Resolution to Exceed The Levy Limit that will increase town levy limit by \$10,000. Motion carried unanimously on voice vote 6 Aye, 0 Nay, 0 abstained.

Motion to recommend to the Board of Supervisors the proposed Town 2021 Budget by Gary Frankiewicz; seconded by Joan Avery. Motion carried unanimously. *It is noted that the Notice of Town of Spooner Special Meeting of Electors was posted at least three places (AAA Sports Shop, Bulik's Mobile Home Park, Spooner Lake Town Billboard, Town Hall bulletin board, Spooner Advocate and posted www.townofspooner.com) at least 15 days prior to November 10, 2020 and not more than 20 days before November 10.*

Motion by Miles Macone to approve the 2020 Total Town Tax Levy of \$166,475 to be collected in 2021 pursuant to Section 60.10(1)(a) of Wis. Statutes; seconded by Gary Frankiewicz. Motion carried unanimously.
